- 22. Public Comment: Steve Shoemaker reported that a resident reached out to the Citizen's Road Committee regarding the bridge on 140th St near Division. Discussed previous inquiries to the Allegan County Road Commission regarding the cost of replacement. Replacement of this bridge will not be on the agenda in

the near future. Supervisor Wolbrink will reach out to the Road Commission regarding the possibility of replacing the planks on the bridge.
